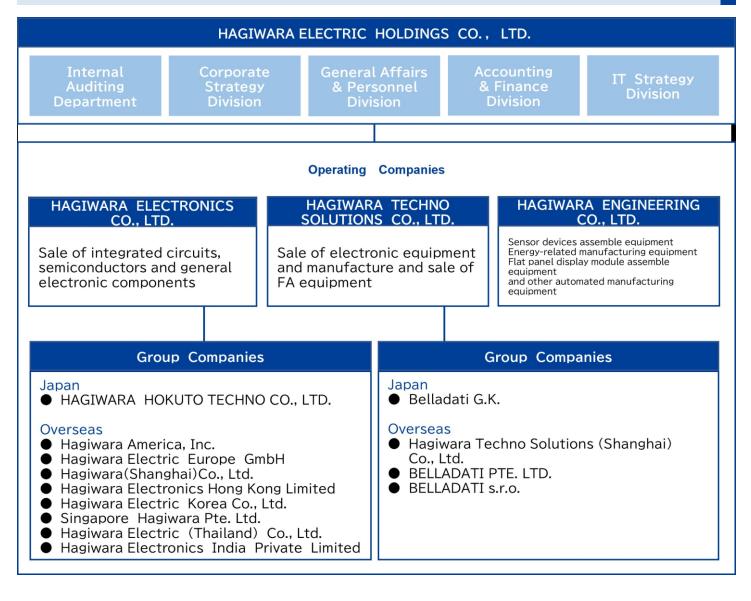

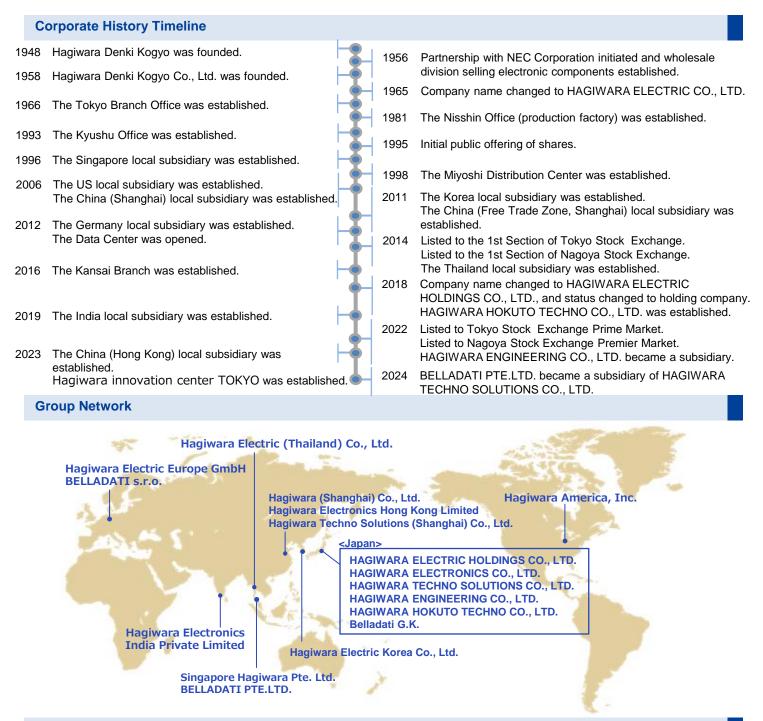
Organizational structure of the Group

As of April 1, 2025

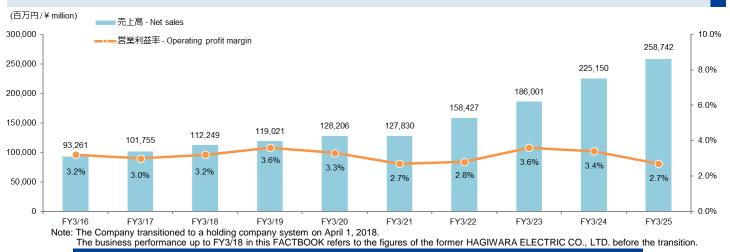
