### Notice Regarding the Organization, Officers, and Corporate Logo in Connection with the Establishment of MIRAINI Holdings Co., Ltd.

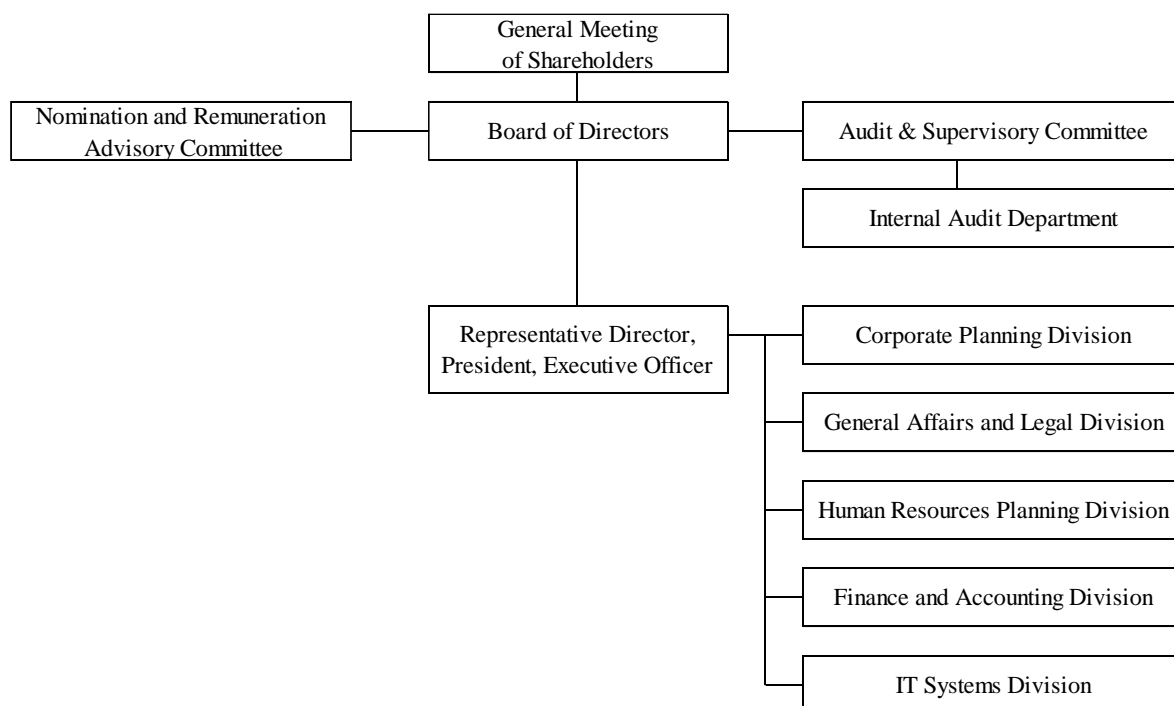
